Applications are invited from the interested Non-Government Organisations (NGOs) for implementation of After Care Programme in the District for the inmates of Child Care Institutions(CCIs) leaving from the CCIs after attainment of 18yrs. of age . The applicant NGOs should submit the following documents /certificates with their application.

- A copy of certificate of registration under the Juvenile Justice (care and protection of children) act, 2015. childrens'
- Five years of experience in management of a home.
- Minimum three years of experience in assisting children with vocational training.
- Minimum three years of experience in placement of children in jobs, apprenticeships etc.
- A well established counseling Programme.
- Existing Children's homes to be considered for running after care home for girls in separate premises.

Services to be provided by the after care organization:

The after care organization shall essentially provide for every child:

- Housing facility, for a maximum period of 3 years as per selected model.
- Professional emotional and psychological counselling on a weekly basis.
- Health care through tie ups with nearby medical centers/doctors.
- Vocational training facilities through tie ups with educational institutions teaching certified skill development courses under 'State skill development programme'/ 'National skill development programme'/ITCs and other recognized vocational training institutes. The aim is that the child is prepared for employment through a certificate course and can be gainfully employed thereafter on this basis.
- Assistance in opening bank accounts and for getting identification such as "aadhar" number, ration cards, voting cards, etc.
- Out of pocket expenses during the course of the vocational training till such time that the

youth gets employment.

In addition the above, assistance would be provided for the following:

- If the child is interested in education, in addition to the vocational training, he/she may be encouraged/assisted to pursue the NIOS programme.
- Training, apprenticeships and placement in collaboration with professional agencies and corporate. This may include convergence with labour department and other agencies for skill development.
- Arranging loans for entrepreneurial activities along with professional advice and training.
- Peer counseling.
- Legal services that may be required by the child through DCPU or linkages with other organizations.
- Computers, recreational material and other facilities at the place of stay.
 Specialized counseling services in polyclinics may be provided to those children who have disciplinary issues, problems of substance abuse, frequent absenteeism etc. So that they can be mainstreamed into society

The applications for implementing the After Care programme in the District must reach to the District Child Protection Unit, Balangir (infront of Collectorate) on or before 18th. November 2020 by Registered post / Speed post. Details of the After Care Programme is available in the Office of the District Child Protection Officer, District Child Protection Unit, Balangir.
